2. Respect all property boundaries. Do not remove, alter, change, paint, mark, or deface said markers.
3. Take every precaution against fire, littering, or impact I may have on the area or surrounding area.
4. Remove no physical items other than what I have been permitted.
5. Obey all laws; local, state, and federal.
6. No use of ATV's or motorized vehicles permitted, except those parked in designated areas.
7. Leave the property in better condition than it was prior to my visit.
8. This permit does not imply access by any other person other than what is specified on this permit.
9. Report any violations to OVCC that are suspected or witnessed.

I understand the Ohio Revised Code #1533.181 that states:

Ohio Revised Code 1533.181: Exemption from liability to recreational users

(A) No owner, or lessee, or occupant of premises:

- (1) Owes any duty to a recreational user to keep the premises safe for entry or use;*
- (2) Extends any assurance to a recreational user, through the act of giving permission, that the premises are safe for entry or use;*
- (3) Assumes responsibility for or incurs liability for any injury to person or property caused by any act or a recreational user.*
